Ms. Sangeeta Kore, IQAC Chairperson then introduced the university and management nominated members of the council.

The Minutes of the first meeting of Academic Council held on 12th Dec 2020 was considered as read and approved by the Academic Council.

Principal requested the University and the management nominees to give their suggestions

The University nominees approved the changes in the syllabi as presented.

Thereafter CS Charul Patel Controller of Examinations presented the changes in the Examination pattern, question paper pattern and evaluation methods as approved by all the Boards of Studies.

She informed that it would be Choice Based Grading System with uniform exam pattern for all courses- 60/40 pattern of evaluation - 60(external) /40(internal) pattern and 10 point grading.



The meeting was informed that the approved Examination pattern for first year courses in the academic year 2020-21 will be continued in the academic year 2021-22. Under unforeseen circumstances, examinations / evaluation will be through on-line or any other mode as directed by UGC/ Govt./ University.

The meeting was informed about the successful in-house digitalisation of examination & result declaration process.

This was followed by the presentation on existing and proposed short term courses by IQAC coordinator, Ms. Sangeeta Kore.

Thereafter CA Prasanna Tambe informed about the proposed Finance Leadership Program in collaboration with CIMA, U.K..

Dr. Parag Ajgaonkar enquired about the evaluation pattern of short term courses. He also asked if it is only for in house students or open for all.

IQAC coordinator informed the evaluation parameters such as tests, assignments, presentations, projects and viva voce.

The Principal informed that the courses are open for in-house as well as outside students through S.I.E.S. Centre for Excellence.

Dr. D.V. Pawar enquired whether all faculty for short term courses were in house and whether there is a revenue sharing model . Principal replied that the courses had a blend of internal as well as external faculty. A 70:30 revenue sharing model is followed for courses by external agencies.

Mr. Arvind Narayanan asked whether the content and delivery is checked for quality. Also whether there was any filter for selecting courses.

Principal clarified that the courses were selected mostly based on employability and reliable certification. Feedback from students is collected to assess suitability and effectiveness.

Mr. Venkataramani asked if the certification is provided by agency or jointly with SIES. Principal said that the certification is provided by S.I.E.S C & E /jointly by SIES and the agency/ Agency as applicable.

Dr. Smita Shukla suggested that the college should seek clarification about GST implication of educational courses. CA Prasanna Tambe clarified that GST is applicable only for those courses which are not recognised by University of Mumbai.



CA Prasanna Tambe said that the college is planning for short term courses or diploma courses in collaboration with some autonomous colleges.

Dr. D.V. Pawar appreciated the range of short term courses being offered by the college.

As there were no further suggestions and points of discussion, the meeting ended with a vote of thanks by Vice Principal, Dr. Shanti Suresh.
