4. Students who passed HSC examination before June 2022 should submit the gap certificate in a stamp paper.
5. Students who have passed HSC from other boards should complete the formalities for eligibility certificate in the college office & then complete the admission process.
6. Adhar Card Xerox copy .
7. ABC ID Xerox copy if available .

The students who are offered admission are required to complete the admission formalities with valid documents and confirm their admission as per the above schedule. The **offer** of admission **stands cancelled** if the **admission** is **not confirmed** on the date & time specified.
