The list of the eligible candidates and date of interview will be notified on the college website siesce.edu.in and on the notice board of the college in the **first week of September 2026**.

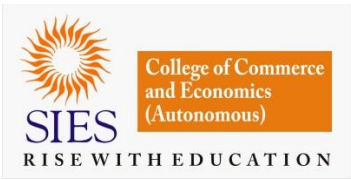
